# **GENERAL INFORMATION:**

### Purpose

The Tennessee Beef Heifer Development Program is to incentivize the re-population of the beef herd through custom heifer development. It will be accomplished by the implementation of management practices with access to more productive replacement females allowing for more rapid expansion of Tennessee's beef herd. This will improve the longevity of these females, decreasing turnover and providing for exponential improvement in genetics with associated revenue generation.

# Benefits

The program is a partnership of The University of Tennessee Institute of Agriculture and the Tennessee Department of Agriculture designed to:

- Increase the opportunity for custom replacement heifer development.
- Demonstrate proper replacement heifer development to beef cattle producers in Tennessee.
- Increase the implementation of heifer development practices that will result in optimum reproductive efficiency as mature cows.
- Demonstrate management techniques necessary for replacement heifers to reach target weight and breed successfully.
- Demonstrate methods of evaluating heifers for disposition, performance, and reproductive traits.

# **Reproductive Management**

Heifers were synchronized and bred AI (artificially inseminated) (Nov 20<sup>th</sup>-22<sup>nd</sup> 2024). They were observed for a natural heat for a second round of AI (Dec 9<sup>th</sup>- 13<sup>th</sup>) and then pasture exposed to UT angus bulls (Dec 16<sup>th</sup>- Feb 27<sup>th</sup> 2025).

# **Nutritional Management**

Heifers were maintained on high quality hay and 14% course grain during winter months. During grazing heifers were rotated between a mixture of native warm season grasses, rye grass, and fescue pasture. They were allowed free choice reproductive mineral though out the program.

# Health Status

All heifers were tested and negative prior to or at arrival for Anaplasmosis and BVDV-PI. Heifers were vaccinated at the Tennessee Beef Heifer Development Program for IBR/BVD/PI3/BRSV, and 7-way Clostridial, & dewormed (July 2024). Spring vaccines were given on May 19<sup>th</sup> 2025: Triangle 10 HB, Alpha 7/MB1, dewormed, and fly tagged.

# **TERMS AND CONDITIONS OF SALE:**

- 1. Each animal will be sold to the highest bidder without reserve.
- 2. The auctioneer will settle any dispute as to bids and his decisions on such matters shall be final. Cattle will remain property of the consignor until sold.
- 3. Each animal will become purchaser's risk as soon as sold, although every precaution will be taken to ensure their safety.
- 4. A certificate of registry and transfer may be furnished at the discretion of buyer and consignor for eligible animals.
- Heifers were diagnosed pregnant on March 18<sup>th</sup> to 21<sup>st</sup> 2025, and confirmed again on May 19th, 2025.
- 6. All heifers are guaranteed to be bred for 30 days after the sale. A buyer purchasing any heifer found open (by an accredited veterinarian within 30 days of the sale) will be refunded by the consignor.
- Claims for refund or other adjustments. All claims for adjustment or refund for any reason must be in writing within 30 days of the sale and it will be settled by the consignor.
- 8. Everything possible will be done to prevent accidents. However, if any should occur, neither the owners, sales management, or other persons connected with the management of the sale, assume any liability, legal or otherwise, to persons or property. The University of Tennessee does not assume any liability for injury to the animals.
- 9. The terms are cash or check.
- 10. The above guarantees and terms shall constitute a contract between the buyer and seller of each lot and shall be equally binding upon both. Neither the sale manager nor any other person connected with the management of the sale assumes liability, legal or otherwise. The University of Tennessee does not assume any liability for any legal guarantee or condition of sale.
